EUROPEAN Open, Mixed & Youth Tornado Championship **2020**

24th - 28th- June 2020

NOTICE OF RACE

1. ORGANIZING AUTHORITY

The Organizing Authority is the SCFF - Segelclub Füssen Forggensee, on behalf of the International Tornado Association (ITA), and World Sailing – A Sport for life. SCFF – Augsburgerstr.78, 87629 Füssen

2. RULES

2.1. The regatta will be governed by the Rules as defined in the Racing Rules of Sailing (RRS).

2.2. The ITA Class Rules "Appendix C - International Events" and the "Equipment Inspection Regulation" will apply.

2.3. No national authority prescriptions will apply.

2.4. If there is a conflict between the Sailing Instructions and the Notice of Race, the Sailing Instructions shall prevail (this changes RRS 63.7).

2.5. A boat chartered or loaned for the regatta may carry national letters or a sail number in opposition of the Class Rules only after the agreement at registration (see RRS AppendixG.3).

2.6. If there is a conflict between languages, the English text will take precedence.

3. ADVERTISING

3.1. Competitors may be required to carry advertising chosen and supplied by the organizing authority.

4. ELIGIBILITY

4.1. All competitors shall meet the requirements of World Sailing Regulation 19.

4.2. All competitors shall be current members of the International Tornado Association (ITA), and of a local National Tornado Association, if the latter is available in their home country; their current year membership fees shall have been fully paid and verified.

5. ENTRY

5.1. The regatta is open to eligible boats of the Tornado Class.

5.2. All Eligible boats may enter by completing the Official Entry Form published on Internet Website <http://www.scff.de/> and submitting it by e-mail.

5.3. An eligible boat's completed Entry Form and Entry Fee shall be received by the Organizing Authority to mail address TornadoEMC2020@scff.de no later than 18th of June 2020.

6. FEES.

6.1. The Entry Fee is 350€ until May 30th, 2020 after May 30th it is 400€. All Entry Fees include 50€ as the ITA event fee, prices are per boat.

6.2. An Entry Fee shall be paid at the same time the request for entry is sent. The Entry Fee shall be sent by bank transfer ONLY to:

The money transfer should specify the helms name, nation code and sail number. This is required in addition to the submission of the Official Entry Form.

The transfer costs must be paid by the applicant. In the opposite case, the difference shall be paid at the Registration.

6.4. Entry Fees are NON REFUNDABLE

7. SCHEDULE

7.1. Registration, Equipment Inspection, and ceremonies:

24.06.20	Measurement until 12hrs & Racing from 14hrs (2 races)
24.06.20	Opening Ceremony 19.30hrs
25.-28.06.20	2 races/day; First race warning signal (ws) time: H 11.00
28.06.20	Prize giving ceremony after races

7.2. Eight (8) races are scheduled for the regatta.

7.3. Dates of racing:

RACE PROGRAM:

24.06.2020 2 races/day; First race warning signal (ws) time: H 11.00
25 to 28.06 2 races/day; ws time will be posted by 21hrs of the day
before
28.06.20 No warning signals after 15hrs will be given

8. EQUIPMENT INSPECTION

8.1. Equipment Inspection shall be conducted in accordance with the Tornado Equipment Inspection Regulations, copies of which will be available on the event website and at the Race Office from 10th June 2020.

8.2. Each boat shall present a valid measurement certificate at equipment inspection.

8.3. Competitors may sign up for an inspection time slot at the race office during registration.

9. SAILING INSTRUCTIONS

The Sailing Instructions will be available on June 20th, 2020 at the Registration Office.

10. VENUE

Boat park will be located on the SCFF grounds.

The race area will be on the waters of the Forggensee

11. THE COURSE

The Championship Course, as shown in Class Rules Appendix C, will be used.

12. PENALTY SYSTEM

12.1. RRS 44.1 and RRS 44.2 will be changed so that only One-Turn penalty including one tack and one gybe is required.

12.2. RRS 44.3 will not apply.

12.3. Decisions of the International Jury will be final as provided in RRS 70.5.

13. SCORING

13.1. 3 (three) races must be completed to constitute a series.

13.2. When 5 (five) or more races have been completed, a boat's worst score will be excluded from the series score.

13.3. The Low Point System of RRS Appendix A will apply.

13.4. There will be a final official ranking list for the World Sailing Tornado Open European Championship, for the Mixed European Championship, for the Youth European Championship and for the Classic European Tornado Cup.

14. SUPPORT BOATS

Team support boats have to register at Registration desk and have to display their national flag and any other identification mean provided by the Organizing Authority.

15. RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

16. PRIZES

Prizes will be given as follows:

- (a) Trophies will be awarded to the top overall 5 finishing boats.
- (b) Trophies will be awarded to the top 3 Mixed teams.
- (c) Trophies will be awarded to the top Youth teams (both crew members need to be under 26 years old on December 31st 2020)".

17. SOCIAL EVENTS

Any further Social events scheduling will be posted during the event and will be posted on the official board of the Sailing Club.

18. DISCLAIMER OF LIABILITY

Competitors will sail at their own risk, See RRS 4, Decision to race. The organizing authority, ITA and all parties involved in the regatta organization will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

19. INSURANCE

Each participating boat shall have current third-party liability insurance with, including coverage when racing at the venue of the championship, of not less than 1.000.000€ per incident (or equivalent). Proof of this insurance shall be available at all times.

20. PHOTOGRAPHY CONSENT

By entering the Championship competitors accept that they may be photographed and/or videotaped participating in the race and/or using the regatta facilities and they consent to the taking of such images and to the use, re-use, publication and re-publication of such images in any media, in conjunction with the competitor's name or not, without compensation and without the competitor's approval of such images or any use thereof.
